A meeting was held to discuss the T6 heat treatment furnace investigation due to some historic breaches of the ELV of 5mg/l for particulates.

Process control standards were checked and benchmarking against other plants was difficult due to the unique feature of the Deeside plant. During the investigation and stressing of the process over the 2 month investigation, no exceedances of the particulate ELV were observed.

The Operator has concluded that due to uncertainties a cartridge filter will be fitted as a guarantee to always meeting the ELV. It is proposed to install this during the next shut down commencing 13th August 2014. Natural Resources Wales is to advice on any requirements for a Permit Variation.

The Operator has been involved in a benchmarking exercise against the other European manufacturing facilities. It is helping to identify the emissions likely to cause the highest risk of non-compliance with permitted ELVs. The proposal is to look at the CO emissions from the melt towers next. Investigations with some monitoring are likely to take place from mid September until the end of the year.

It was agreed that compliance monitoring could be delayed until the end of the year following the investigations.

The Operator also stated that there is a greater risk of exceeding the ELV since the monitoring has changed from a 4 hour reference period to a 1 hour reference period, this is likely to be due to the nature of the process, particularly charging of the furnace. Natural Resources Wales will review this and report back.
