Site Inspection

A site walkover of the permitted areas to include the casting building, waste management and waste water areas was undertaken. Housekeeping was noted to be of a very high standard.

Compliance

C1 - Permit Condition 1.1.3

The Permit available at the entrance to the casting building was V003 issued 27th October 2009. Variation V004 issued 21st February 2011 updates the Permit to allow for recovery of swarf. The Operator is to ensure that procedures are in place and implemented for making updates to the permit, i.e the correct version, readily accessible. CCS4 - No likely impact as the Operator was actually aware of the variation which was simply to include for the recovery of swarf.

Accident Management

Major Emergency Management Sub-Policy P-KBH2.1v2 was received and reviewed. This procedure is of a high standard with scope, definitions, examples, escalation guidelines, roles and responsibilities, process decision trees, risk assessment, signposts to other relevant procedures/material, and recording templates. This procedure is relatively new with a start date of 15/03/13. It is reviewed annually and testing is undertaken with that recently done at the Burnaston Plant in March of this year.

Advice and Guidance - The Operator is advised to consider the eventuality of evacuation of the site and issues this may bring with regard to access to relevant information and resources, should such an event occur.
