On the 9th of May 2019 Environment Officer, Edward Davies, conducted a routine inspection of the sewage treatment system at Monmouth Services North. It was raining at the time of the inspection.

Met with site manager David Prosser, treatment plant was operating, alarm was not going off and power was clearly being supplied to the plant. Visually inspected discharge point, effluent quality appeared good, no sign of any sewage fungus.

The discharge point was fairly overgrown making the sign not immediately apparent.

Mr Prosser confirmed that Eurogarages Limited have the treatment plant maintained on a contract with Mayglothing Waste, who inspect the system every 4-6 weeks and take samples of the discharge.
