This change of address was not notified to us and I consider that Margam Green Energy Limited have not complied with condition 4.3.4 (a) with respect to the registered office address that has changed from a Cardiff address to one in Manchester.

Whereas this is an administrative non-compliance with no environmental impact it is a non-compliance with the permit. This is the first non-compliance by the company and there may be mitigating circumstances within the company at that time.


It important that all officer and employees of the company are aware of the requirement of, and their responsibility under the permit. It should be noted that there are requirements within the permit that required action before the start of commissioning.

We note that you have since notified us of the change of registered address and have noted the change on our permit administrative system.
