Margam Green Energy Plant (MGE) is controlled by an environmental permit to incinerate non-hazardous waste. The permit implements the requirements of the European Union Directive on Industrial Emissions and section 2.5.1 of that permit specifies that:

The activities shall not be brought into operation until the measures specified in schedule 1 table S1.4 have been completed.

Twelve pre-operational conditions (PO) were specified in the permit and this compliance assessment report form has been produced to acknowledge the submission of PO3; PO4 and PO6.

These conditions are produced below:

PO3	At least 5 months prior to the commencement of commissioning, the Operator shall submit a report on the baseline conditions of soil and groundwater at the installation. The report shall contain the information necessary to determine the state of soil and groundwater contamination so as to make a quantified comparison with the state upon definitive cessation of activities provided for in Article 22(3) of the IED. The report shall contain information, supplementary to that already provided in the application Site Condition Report, needed to meet the information requirements of Article 22(2) of the IED.
PO4	At least 5 months prior to the commencement of commissioning, the Operator shall submit a written report to Natural Resources Wales which provides a detailed summary of the site's hydrogeology, including groundwater flow direction and a brief description of aquifer properties (for example porosity and permeability). The report shall also include a detailed site drainage plan as built.
PO6	At least 4 months prior to the commencement of commissioning, The Operator shall submit the written protocol referenced in condition 3.1.4 for the monitoring of soil and groundwater for approval by Natural Resources Wales. The protocol shall demonstrate how the Operator will meet the requirements of Articles 14(1)(b), 14(1)(e) and 16(2) of the IED. The procedure shall be implemented in accordance with the written approval from Natural Resources Wales.

The expertise for assessing these submissions does not sit within the Industry Regulation team and as such we sought the advise of our geoscience team. It provided a review of the pre-operational conditions and also attended a meeting with the operator and its consultants (terra firma) 15 May 2017.

The operator confirmed that it has not submitted a definitive list of chemicals using the classification, labelling and packaging regulations (CLP) as at this stage as the specific raw materials have not been secured. It was agreed that these can be submitted one month before commissioning. Therefore PO3 is not completed and will be extended until 1 month before commissioning. All other aspects of PO3 are satisfied.

Groundwater flow and baseline protection from offsite sources are required to be assessed further to be able to complete PO4. We agreed that the groundwater flow will need to be triangulated to confirm the direction of flow as this was assumed in the submission. The operator agreed that this would be carried as soon as practicable. PO4 is

ongoing.

The measurement suite for groundwater and soil sampling is still being prepared and will be completed when the aspects of the CLP (discussed above) have been satisfied. Once this has been completed, we will assess the submission. PO6 is still ongoing and can be submitted in line with PO3 i.e. 1 month prior to commissioning.
