FENCING

1. All fencing materials, workmanship etc. shall be in accordance with BS 1722 part 5:2006 and part 2:2006, and clause 306 of the Specification of Highways Works.
2. All timber posts shall be placed to their correct depth and their tops and bottoms SHALL NOT BE CUT to compensate for difference in level.
3. Timber preservation shall comply with BS 8417-2-11+A1:2014 and BS 144:1997 (creosote Preservation).
4. Certificates showing the serial number, timber species, moisture content, preservative treatment and cycle employed shall be provided with each batch of timber.
5. Longer posts will be required when the fence line is located either along or with the slope of an embankment. Fence lines located at the top to use the standard lengths as shown if clearance is available for stability, otherwise use longer posts as stated.
6. Where plain or barbed wire is required it should be zinc coated and comply with BS EN 10223-1:2012.
