Comments

1. Tower Jetting Procedure

Thank you for providing the revised kiln riser cleaning guidance note / procedure dated 11/04/14. I have reviewed the procedure and believe it is fit for purpose and I have no further comments. Please ensure all relevant personnel receive appropriate procedural training by 13/06/14

2. Hot Gas Generating - Dust Release

On 07/02/14 a member of the public reported seeing dust coming from the tower and falling onto fields immediately to the rear of the kiln / pre heater tower area.


Castle Cement investigated the complaint and confirmed that the incident was linked to plant operations. At the time of the incident a process known as hot gas generating was underway to allow the operation of the raw mill and production of raw meal when the kiln was not operational.

To protect the system from overheating an access door on a pre-heater cyclone was opened to create a cold air bleed. During this process the kiln ID fan tripped causing dust and fumes to be released from the cyclone door until it was manually closed shortly after.

This incident constitutes an unauthorised emission to air and is in breach of permit condition 3.1.1 and attracts a CCS score of 3. It is not acceptable to use a cyclone door in this manner and accordingly we require that you assess alternative options and implement a system that prevents further unauthorised emissions to air when this process (hot gas generating) is in operation. Please inform Natural Resources Wales of your intended actions by 31/07/14 along with timescales for completion.

3. Packing Plant

During the inspection it was confirmed that cement bag packing is due to re-commence on site. Changes to the bagging plant / buildings etc were briefly discussed. I would like to cover this issue in more detail during the next scheduled site visit on 24/06/14.
