### 1. Dust Emissions

Further to our meeting please provide the following information to NRW by 31/08/16.

- It is understood that incidents reported to Castle Cement by NRW 18/03/16, 06/04/16 and 18/04/16 may have occurred during kiln jetting and kiln shutdown. Please confirm the nature and root cause of these incidents.

- Clarification is required as to the control measures that were in place to prevent minimise dust emissions relating to the above incidents and details of any addition or amended control measures (physical, procedural etc.) that have since been put in place to prevent a recurrence.

### 2. Pollution Prevention Audit Actions

I acknowledge receipt of your letter dated 05/08/16 confirming that the following actions have been completed;

- The site drainage plan has been issued to the IMS under UKCP09 Emergency Response.
- The Emergency Response plan has been reviewed and additional wording has been added to make specific reference to both water outfalls.
- The local Padeswood procedure for accident and emergency has also been updated to reflect both outfalls.
- Changes have been notified to senior managers and shift managers.

Following the update to the procedure I note your intention to provide pollution prevention awareness training to drivers using the vehicle re-fuelling area.

The procedure and training records will be reviewed by NRW during the next inspection.

I welcome your commitment to install an emergency shut off penstock post interceptor (emission point W2) and acknowledge your plans to install a new septic tank for the wash room adjacent to mill 3. Please ensure both actions are complete by the end of Q1 2017.

### 3. Operator Monitoring Assessment

I acknowledge receipt of your response to the OMA audit of 23/06/16, we will review the information provided and respond in due course.
