This Compliance Assessment Report covers a review of routine monitoring data for the period 1st January to 31st March 2013 for continuous monitoring for all permitted emission points to air and also emissions to water.

Emissions Monitoring

Monitoring data for emission points W1 (water) and A1 - A9 (Air) received as required on 25th April 2013 - thank you.

a) Emissions to Water (W1)

All parameters within permitted limits.

b) Emissions to Air - Continuous Monitoring (A1 - A9)

During this period there was a single emission limit breach for emission point A8 on 28/02/13. The NO_x daily average was recorded at 549mg/m³ (emission limit 500mg/m³). Part A & B notifications received - thank you.

This emission limit breach attracts a CCS score of 4. Breach of permit condition 3.1.2. The cause of the breach was due to the SNCR system failing to respond rapidly enough to changing kiln conditions. The operator has introduced a more aggressive NO_x reduction recipe (using SNCR) to increase the rate of ammonia injection more quickly than previously as the NO_x levels rise in the stack emission. Progress to be tracked by NRW.

c) Emissions to Air - Periodic Monitoring (A8)

Periodic monitoring for emission point A8 (kiln) not reported during this period. Due in the next monitoring return.
