### Comments

This Compliance Assessment Report covers a review of routine monitoring data for the period 1st October 31st December 2013 for continuous monitoring of all permitted emission points to air and also emissions to water. It also covers a review of periodic emissions monitoring of emission point A8 (kiln) and the annual WID report.

#### 1. Emissions Monitoring

Monitoring data for emission points W1 (water) and A1 - A9 (Air) received as required on 27th January 2014 - thank you.

- a) Emissions to Water (W1) All parameters within permitted limits.
- b) Emissions to Air - Continuous Monitoring (A1 - A9) During this period there were no emission limit breaches for emission point A8.
- c) Emissions to Air - Periodic Monitoring (A8). Periodic monitoring data for emission point A8 (kiln) has been reported for the last 6 months of 2013. All emissions are within permitted limits.

Thank you for providing additional information with regards to 6 monthly kiln bypass dust analysis

#### 2. Annual Report
