All parameters within permitted limits.


b) Emissions to Air - Continuous Monitoring (A1 - A9)

During this period there were no emission limit breaches for any emission points.

c) Emissions to Air - Periodic Monitoring (A8)

Periodic monitoring data for emission point A8 (kiln) has been reported for the first 6 months of 2013. All emissions are within permitted limits.

d) Ambient air quality monitoring data for Jan - June 2013 was due for submission end of July 2013. The report has not been received which is a breach of permit condition 4.2.3. CCS4. Please provide the report by 23/08/13.
