This Compliance Assessment Report covers a review of routine monitoring data for the period 1st January - 31st March 2015 for continuous monitoring of all permitted emission points to air and also emissions to water.

### **1. Emissions Monitoring**

Monitoring data for emission points W1 (water) and A1 - A9 (Air) received on time - thank you.

#### **a) Emissions to Water (W1)**

All parameters within permitted limits.

#### **b) Emissions to Air - Continuous Monitoring (A1 - A9)**

During this period there was a single emission limit breach at emission point A8 (kiln). NO<sub>x</sub> was recorded at 543mg/Nm<sup>3</sup> (daily average limit 500mg/Nm<sup>3</sup>) on 05/02/15. This is a breach of permit condition 3.1.2, CCS4.

A Part A notification was received as required.


A subsequent Part B notification was received 04/03/15 stating that '*NO<sub>x</sub> values were holding steady up to 13.30 with the SNCR operating at control levels. The levels then rose but the SNCR system failed to control to set point for around 3 hours until the levels then returned to the control point. Investigations showed the main shut off valve to not be operating fully limiting flow into the system*'.

Remedial action was reportedly taken to free the valve to restore the system function.

A number of NO<sub>x</sub> exceedances relating to the operation of the SNCR system have occurred including on 06/09/14 and also one outside the period of this review on 04/04/15. Please inform Natural Resources Wales of the action you are taking / have taken to improve the reliability of the SNCR system to ensure compliance with the NO<sub>x</sub> ELV, please do so by 15/05/15.

#### **c) Emissions to Air - Periodic Monitoring (A8)**
