This Compliance Assessment Report covers a review of routine monitoring data for the period 1st April - 30th June 2015 for continuous monitoring of all permitted emission points to air and also emissions to water.

### **1. Emissions Monitoring Monitoring data for emission points W1 (water) and A1 - A9 (Air) received.**

#### **a) Emissions to Water (W1)**

All parameters within permitted limits.

#### **b) Emissions to Air - Continuous Monitoring (A1 - A9)**

During this period there was one emission breach at emission point A8 (kiln) - NO<sub>x</sub> was recorded at 668mg/Nm<sup>3</sup> (limit 500mg/Nm<sup>3</sup>) on 04/04/15. A Part A notification was received as required.

A subsequent Part B notification was received 03/08/15 stated that *'Kiln 4 was struggling to run consistently due to blockages in the tower and at the third restart of kiln feed at 14:40 the SNCR failed to auto run due to an unacknowledged return fault. This was only confirmed later in the evening when the controller noticed the high running NO<sub>x</sub> on the control screen, He restarted the SNCR at a low set point to drive down the emissions, and lowered again later to attempt to mitigate the results. However there was insufficient running time to midnight to fully reduce the output.'*


Corrective action taken – *'a software modification was added to the control system to automatically restart the SNCR when appropriate kiln limits are reached.'*

This is a breach of permit condition 3.1.2, with potential for negligible environmental impact, CCS4.

There have been no further NO<sub>x</sub> emission limit breaches since this date.

#### **c) Emissions to Air - Periodic Monitoring (A8)**

Periodic monitoring data for emission point A8 (kiln) received covering January - June 2015 - all parameters within the permitted limits (where limits apply).
