This Compliance Assessment Report covers a review of routine monitoring data for the period 1st October - 31st December 2015 for continuous monitoring of all permitted emission points to air and also emissions to water. It also covers periodic monitoring for the period 1st July – 31st December 2015.

1. Emissions Monitoring - Monitoring data for emission points W1 (water) and A1 - A9 (Air)


- a) Emissions to Water (W1) - all parameters within permitted limits.
- b) Emissions to Air (A8) Periodic Monitoring – all parameters within permitted limits.
- c) Continuous Monitoring (A1 - A9) - all emissions compliant with the exception of the following;

A single emission limit breach at emission point A7 (Cement Mill 4 classifier) on 15/10/15. The daily average was recorded at 34mg/m³ (ELV 30mg/m³). Part A notification received as required.

Part B notification received 25/01/16 reported that (in summary) trends were being monitored prior to this event and did not show any major cause for concern. Filter emissions rose abruptly and the mill was taken out of production. The filter was inspected and 2 bags in poor condition were identified and replaced.

Subsequent to this event a repair was required to the mill post-Christmas running that took it out of operation for 2 days and the opportunity was taken to change 4 out of 6 banks of the filter system. It is calculated at less than 1kg excess emission over 24hrs, would have dissipated rapidly and no complaints were received linked to this event.

This is a breach of permit condition 3.1.2, with potential for negligible environmental impact, CCS4.
