### CQA Plan - Ground Water and Gas monitoring borehole

Condition 2.7.4 of the permit states "No construction of landfill infrastructure shall commence until the operator has submitted relevant construction proposals or a written request to use previous construction proposals and the Agency has confirmed that it is satisfied with the construction proposals.

Compliance assessment of the CQA plan for the installation of gas and ground water monitoring boreholes at Cwmrhydyceirw landfill was completed and initially responded to via email dated 10/7/18 in which it stated:

"I will send a CAR form confirming this satisfaction of the CQA plan for the boreholes later this week, but please accept this email as confirmation that drilling, and works can commence."

Assessment of the CQA plan was fully completed following submissions by MJCA (acting consultants for operators SI Green) by NRW waste regulation and geoscience team.
