No ammonia releases in 2021 reported.

Summary;

Open discussion between Operator and Regulator on challenges faced for reporting during the year given staff changes.

No significant findings, temperature spikes and reporting of effluent outfall to be further investigated as part of a future OMA, hopefully within 2022. These have been well explained by the Operator.

BOD values in Q2 were raised but within the claimed uncertainty, these may also be considered during the OMA.

Encouraging to see the impact of the wind turbine in terms of reduced CO2 production. On-site discussion positive around future environmental emissions.

Risks to the environmental performance appear to be focused on the potential for natural gas supply interruption due to external geo-political situations.

Potential to review the Biogas use in terms of scrubbing and whether the maintenance programme could be improved to reduce H2S values.

Also please note changes to future reporting requirements due to permit changes in Permit version V008 and plan accordingly.
