Monitoring Returns for the Period July 2013 to December 2013 inclusive were submitted in accordance with timescales required by the Permit. The following breaches of Permit limits for effluent from the ETP to the Afon Erch via A1 were recorded and notified via Part A in accordance with Permit requirements:

- Concentration of 596mg/l against limit of 520mg/l Chloride on 03/07/13
- Concentration of 6.09mg/l against limit of 6mg/l Ammonia 11/07/13
- 25.26 degrees Celsius against limit of 25 temperature on 22/07/13
- Concentration of 7.15mg/l against limit of 6mg/l Ammonia 04/09/13
- Flow rate of 11.3 l/s against rate of 9.72 l/s on 21/09/13 (max 15 minute duration caused by blower trip and second coming on. Non-return valve replaced).

E3 Emissions to Surface Water CCS = 3 - Minor breaches of permit limits with minor potential impact on the River Erch for Quarter July to September 2013.

- Concentration of 11.1mg/l against limit of 6mg/l Ammonia 23/10/13
- Concentration of 37.7mg/l against limit of 20mg/l BOD 30/10/13

E3 Emissions to Surface Water CCS = 3 - Minor breaches of permit limits with minor potential impact on the River Erch for Quarter October to December 2013.

The majority of breaches are minor and mostly within test error limits. Internal test results appeared within action limits but lab test results were queried and confirmed.
