Schedule 5 notifications have shown several breaches of permit limit for discharge to the Afon Erch. The breaches in question are for BOD and Chloride.

The latest breach for BOD was detected on the 04th January 2017 and reported to NRW on the 11th January 2017.

Permit condition 4.3.1(b) requires that NRW is notified of such breaches immediately. Please explain the delay in reporting this breach. Failure to report immediately without good reason can lead to further CCS scores. In the future should there be further delays in receiving schedule 5 notifications without adequate reasons the site will be scored under this condition.

Permit condition 3.1 states

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for BOD is 20mg/l and the reported value was 44.6mg/l. This is more than double the permit limit and as such is scored a CCS3 permit breach

The reasons for this breach and other previous breaches (which have not to date been scored) should be investigated and a report submitted to NRW by the 28th February 2017
