A schedule 5 notification for a permit breach which occurred on the 24/01/18, has shown a breach of permit limit for a suspended solids discharge to the Afon Erch.

Permit condition 3.1 states

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3. 3.1.2

The limits given in schedule 3 shall not be exceeded.

The permit limit for suspended solids is 30mg/l and the reported value was 48mg/l. This is scored a CCS3 permit breach.

Once again the breach has been queried with the ALS Lab. The continuing discrepancy between laboratory and kit analysis needs to be resolved. This is essential to ensure that the performance of the effluent treatment plant is properly monitored and assessed. Data must be accurate.
