Dunbia is required to submit quarterly monitoring data for its two water emission points (W5 and W6).

These were received in accordance with the 28 day limit at the end of the quarter. Although the permit specifies a monthly reporting period, this was amended in an exchange of emails and confirmed in an associated CAR form. The amendment has not been reflected in the permit.

All determinands were within permitted limits.

Proposed Ammonia limit increase

In an email to the operator 08 January 2019 we requested that it revisits its quarterly submissions against a proposed increase in the permitted limit for Ammonia at W5 and W6. An increase of 0.05mg/l was suggested and we asked Dunbia to review its submissions going back to Q1 2014. To date this has not been submitted for review. These results will be discussed at the next opportunity.
