Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On 24th May 2022 a routine inspection to assess compliance with your discharge permit was carried out.

No evidence of any sewage, odour, sewage litter or fungus visible at the discharge point, and the treatment plant appeared to be working efficiently.

I would advise that work is carried out to maintain access to the sampling point at the river bank. Condition 4 of your permit states:

"Adequate facilities shall be provided to enable representative samples of the discharge to be conveniently obtained at any time at the discharge to the river...." Although a pathway had been cleared to the top of the bank, the area below was overgrown making the sample point inaccessible which is a breach of permit conditions. As the bank is steep, you may wish to consider providing a safer representative sample point elsewhere? However this is not necessary should safe access to the outfall be provided.

I have given a timescale of 3 months for this action to be carried out.
