### **Review of emissions monitoring for period 1st Jul to 31st Dec 2021 (Q3 and Q4)**

Monitoring reports for emissions to air, water and sewer for Q3 and Q4 were received on 25/10/21 and 26/01/22 respectively for emission points and determinands as required by Condition 2.10.1 of the permit.

All emissions monitoring was compliant with the relevant emission limit values.
