Introduction

This CAR form refers to the Operator's requirement to move from 'red' to 'white' diesel for backup generation, it also covers the option to move to HVO fuel for the same purpose as part of their Permitted operations.

Detail

Vantage informed the Regulator of a requirement for the option to move from 'Red' to 'White' diesel for backup generation on site, including the potential for mixing.

In addition the Operator has previously queried what would be required to be able to move to HVO as a fuel source for the same operation.

This CAR form approves the use of 'White' diesel meeting or exceeding the specifications of the 'Red' version as detailed in the Permit and Permit Decision Document for low sulphur fuels.

It also approves the use of 'HVO' which meets or exceeds the same specifications.

Where the Operator wishes to claim an improvement in air emissions relating to the change to HVO this will need assessment by NRW and is not covered by this CAR form.

Summary

The ability to flex between the various fuels for operational reasons is approved.
