This was received 21/02/14 and found to be complete. Additional plastic packaging as a waste stream was noted.

OPRA Review

An OPRA review was received and accepted.

Annual Submission

The annual reporting information was received 27/01/14.

Monitoring of emissions to air from A1 and A2 for oxides of Nitrogen was undertaken on 03/01/14 in accordance with Permit requirements. The results give no cause for concern.

Data on emissions to sewer was provided. **The Operator is advised to ensure data on flow is provided for the entire year.** The data provided was an average of 9 months.

Performance parameters were provided as required by the Permit for water, energy, and waste. Water usage has decreased slightly since last year, with energy usage showing a slight increase per tonne of product.
