Permitted discharge point was inspected on 1 April 2019 after a pollution incident in the Nant y Cnapiau was reported (WIRS 1901920). Report was of stream running grey at Brecon Close, Hirwaun. This was traced upstream to the culvert leaving tower land at NGR SN 94806 05441. A sample was taken from the right-hand pipe, which originated from the Western overflow (see pictures below).





This sample was sent to and assessed by NRW labs and shown to have a suspended solid concentration of 1420mg/l, which is far in excess of the consented quantity of 50mg/l.

Action

The operator have confirmed that they have taken action. This incident was as a result of a breach of the settlement pond. As a result the site will be issued with a warning and no further action will be taken at this time.
