Full details are in the audit report, but main recommendations are as follows:

QAL3 procedures need to be checked to ensure that calibration is being carried out correctly and that drift or changes in precision are identified and acted upon correctly.

Procedures for changing span gases need to be followed to ensure that they remain in date.

Training of additional staff to deputise for the Utilities Manager in the area of emissions monitoring must be a priority

Other observations:

There had been a leak from the pipe carrying ash to the silos and a considerable quantity of ash was lying on the ground in that area, Although this was unlikely to cause any impact beyond the immediate locality, pipework needs to be maintained to prevent this type of occurrence, and the ash should be cleaned up without delay to avoid it being blown around the site.
