Waste wood mapping

A trial of a new waste wood mapping tool was carried out with a consultant who is developing the tool for NRW. Feedback will be provided on the outcome of this.

Waste wood processing

The new waste wood processing equipment is now fully operational. It is working very well and has significantly improved the removal of ferrous and non-ferrous metal contamination. Dust is collected from the shredders and passed straight into the boiler. Noise shielding had been planned for the project, but has not been installed. The equipment is noisy and will add to the general noise level in the area, but due to the distance from any receptors is unlikely to cause a nuisance.

The new kerbing has been completed to provide fire water containment around the waste storage and processing area. A new procedure for operating the penstocks needs to be written and implemented.

A stockpile of about 1000 T shredded wood, or 3 days fuel is kept in case of a breakdown of the processing plant. The stockpile is rotated so that no shredded material is stored for more than three months.

Dust suppression is available but has not been used so far.

Plant changes

The closure of PM1 is going ahead as planned at the end of March. RCF lines 1 and 2 will also close along with Boiler 1. The fuel oil store will be removed as boiler 6 will run on gas only.

Defra will need to be notified that the site no longer falls into LCP as boiler 3 on its own is below 50MW. The response to the Regulation 60 Notice will also need to state that the requirements of the IED for LCP no longer applies. The boilers will still be a listed activity on the EPR permit as they are >50MW combined.
