(the reference in title to April 2022 was the report completion not works completion)

The report was shared with NRW Geoscience colleagues for assessment. The report concludes that the works were carried out according to the CQA Plan and there were no significant issues during the works. The report states that the restoration soils remain to be placed and a separate CQA Plan will be produced for the works.

NRW can now confirm that it is satisfied with the CQA Validation Report for the permanent capping undertaken in April 2022 in accordance with the requirements of condition 2.7.6 of your PPC Permit

For the outstanding capping works for these sections, in that NRW understand that there is insufficient restoration soils on site, **NRW advise that the site progresses with the proposed permit variation application regards additional waste codes and seeks approval of any source of proposed restoration soils from NRW prior to importing to the landfill site.**

Please note that the acceptance of this CQA Validation by Natural Resources Wales does not mean that the assumptions, designs, specifications, testing regimes will be suitable for any future infrastructure development at the site.
