All returns were submitted as required. There were no breaches of emission limits.

A Category 4 breach of permit condition 4.2.5 has been recorded for the missing waste wood data on the waste return for the incinerator part of the installation. All waste destined for, or coming from the waste wood and incineration operations needs to be included on the waste return. General site waste does not.

The changes recommended following the audit of the MRF sampling procedures have been put in place and the waste return shows the correct number of samples for all materials.
