Valero has to monitor their air and water releases at the frequencies specified in Tables S4.1 and S4.2 of their permit.(G1). They also have to submit a number of annual returns covering a variety of issues such as air releases, energy usages and performance criteria.

They have to report these monitoring results and the annual reports within 28 days of the end of the reporting period. that is specified in Schedule 5 of their permit. All the information should be submitted on the forms specified in Schedule S5.4 of their permit (G4).

The monitoring returns were submitted by three emails on 18/7/2017.

All the results for air and water releases were below the emission limit values and were complaint (E1 and E3).
