Preoperational response submission PO 01 required the submission of a noise monitoring program to NRW for approval. This report was submitted on 26 October 2017. It was designed to satisfy the Pre-operational Condition 01 (P01) shown in Table S1.4B of EPR/YP3930EX/V005.

This submission is in line with the BS4142: 2014 criteria. NRW notes that noise monitoring will be carried out every quarter. We will review each quarterly monitoring data set with Valero to confirm that the data measured is representative, continues to meet the BS4142: 2014 criteria i.e. metrological conditions. It may be that the subsequent noise monitoring work may need to be amended as a result of the NRW/Valero review(s).

### Conclusions

Based on this assessment, the preoperational condition PO 01 has been met and the first round of quarterly noise monitoring can start.
