Introductory note

This introductory note does not form a part of the permit

The following notice is issued under regulation 17 of The Pollution Prevention and Control (England and Wales) Regulations 2000 (S.I.2000 No. 1973 (as amended) (the Regulations) to vary the conditions of a permit issued under the Regulations to operate an installation. The notice comprises schedule 1 containing conditions to be deleted, schedule 2 conditions to be amended and schedule 3 conditions to be added.

This notice implements the requirements of the National Emission Reduction Plan as set out in the Large Combustion Plants(National Emissions Reduction Plan) Regulations 2007 and the Pollution Prevention and Control(Combustion Plants)(England) Directions 2007.

The variation updates the annual emissions limits to air of Particulate Matter, Sulphur Dioxide and Oxides of Nitrogen and their reporting in light of these new regulations.



SCHEDULE 2 – CONDITIONS TO BE AMENDED

2. The following conditions are amended as follows
 - 6.1.4 Where an annual mass limit for a substance is stated in table 6.1.4, the aggregate emission of such substance from the Permitted Installation for the emission points specified in table 6.1.4 shall not exceed that limit in any year.

3. The following conditions are added to the permit
 - 2.11.3 From 1st January 2008, the operator shall inform the Agency of the closure of a relevant LCP within 28 days of the date of closure.
 - 10.1.1 The following definition should be added:-

"NERP Register " means the register maintained by the Environment Agency in accordance with regulation 6(1) of the Large Combustion Plants (National Emission Reduction Plan) Regulations 2007.
