Non-compliances:

No non-compliances were noted during the inspection. However, previous issues with fugitive emissions and efficacy of gas extraction system were not assessed.

Observations:

Site visit accompanied by Environmental Crime Officer - Rachel Clarke. Information related to waste movements to the site was reviewed before the visit, thank you for providing this information.

Prior to the site visit off site odour assessment was carried out - no odour was noted by the inspecting officer in either Llanddulas or Llysfaen area.

The operational area was inspecting during the visit, a large section of the northern flank of Phase 3A North is now permanently capped as a result of recent engineering works on site. A section of this capping was being repaired by Jones Bros contractors during the inspection due to fugitive emissions having been detected by FCC staff, a slight landfill gas odour was present in the vicinity of these repair works.

The operation area also now benefits from around 50 additional pin wells that have been installed to assist with gas collection and odour control. The wells have been positioned in lines close to features and areas that are likely to produce fugitive gas emissions. Gas extraction carrier pipe work has also been upgraded on the operational area to provide a more consistent level of extraction across the field.

Gas well dewatering trial was discussed on site, a total of 8 gas wells currently have pumps installed in them for removing perched leachate. Levels of leachate within the wells and quantities removed are being monitored alongside gas quality and volumes. At present some of the wells involved in the pumping trial have delivered an uplift in gas quality and volume as a result of removing liquid, pressure equalisation valves are also planned to be fitted to some wells to ensure the pumps can operate effectively.
