### Fugitive Emissions Monitoring

#### Quarterly Monitoring report

May-July 2016

**Requirements** - Condition 3.3.5 states the limits for landfill gas arising from the installation shall not exceed the limits set in table S.4.11. Of the permit. The permit requires Flame Ionisation Detector (FID) surveys to be conducted monthly at the site boundary and in the immediate vicinity of gas and leachate well heads and monitoring points.

**Findings** - The FID surveys over this monitoring period showed that on 68 occasions the infrastructure features monitored exceeded the permit limit of 1000ppm. This is a worse performance than on the previous year's quarterly monitoring reports which showed a gradually reducing trend over the year of 45, 35, 21 and 15 breaches consecutively. The increase from the last quarter of the previous reporting year and the first quarter of this year is significant, moving from 15 breaches to 68 breaches, more than a fourfold increase.

This increase means that immediate action should be undertaken to assess the gas extraction infrastructure and ensure all parts are functioning correctly as these results may be a precursor to increased emissions and reduced function on the landfill.

***Please investigate these breaches as a matter of urgency and report your findings within 4 weeks of the date of this report.***

**As a result of consecutive breaches over a sustained period these have been scored a CCS Category 3 breach of permit requirements.**

Please see attached spread sheet detailing the exceedances for the last reporting year and the first quarter of this year (on the second tab). This also allows the tracking of individual feature exceedance over the annual cycle. It was agreed during the site audit on the 26th November 2015 that Infinis will work with the site manager following 2 consecutive breaches at the same feature to identify the problem with the feature and ensure that it does not breach for the third consecutive month. A short bullet point e-mail report should be provided to NRW of actions taken to prevent a third consecutive breach. This action has not yet been undertaken. The consecutive breaches for the last quarter are at the following features:

**D301, LC2BR2, LC2CR, PIN 2, PIN 3 and well D281 breached the limit for 7 months consecutively** before a break in June 2016 only to resume a breach of 5000ppm in July 2016. ***This is unacceptable and such consecutive breaches must be addressed more quickly or the following CAR form will attract a higher score.***
