General Comments:

This site audit follows on from the audit undertaken of gas management infrastructure and performance undertaken on the 05th June 2018. The actions were placed in a tracking document and have largely been expedited. New wells are due to be drilled in October and the CQA plan has been submitted and approved for this activity.

Although the actions required from the last audit have largely been expedited, there were some outstanding issues during the follow up audit particularly with emission from the base of two wells.

E1 Air

Gas wells D309 and D311 on phase 3A, had emissions of 6.1% and 6.8% CH₄ from the base of the wells.

ACTION: Wells should be sealed as soon as possible, and a well dipping programme should be undertaken to establish levels of perched leachate. Pumps should be rotated judiciously between wells or new pumps should be added to the system as there is still an issue with high CH₄/CO₂ ratios in some wells and extraction pressure being close to mains pressure.

All other actions have either been completed or are due to be actioned via the tracker and the impending re-drills.
