Site visit undertaken in response to odour complaints received over the previous 7 days.

No off-site odours were noted prior to, or after the visit in the villages of Llysfaen and Llanddulas adjacent to the site. During the on-site visit some odour was noted on the active tipping area around items of landfill gas infrastructure that had been previously identified with high emissions during the audit in December 2013. Odour was noticeable around the pin wells on the right hand side of the haul road adjacent to Gas Wells D267, D268 & D269 and also around gas well D270 and the nearby leachate tower, although it was not considered excessive at the time. The pin wells adjacent to the haul road were due to be decommissioned and the aforementioned wells are due to be fitted with leachate extraction pumps in order to resolve this issue.
