Fugitive Emissions Monitoring

01st February 2016 - 30th April 2016

Requirements - Condition 3.3.5 states that the limits for landfill gas arising from the installation shall not exceed the limits set in table S.4.11. of the permit. The permit requires Flame Ionisation Detector surveys to be conducted monthly at the site boundary and in the immediate vicinity of gas and leachate well heads and monitoring points.

Findings - The FID surveys over this monitoring period showed that on 15 occasions, the infrastructure features monitored exceeded the permit limit of 1000ppm. This is a significant improvement on the three previous reports in this reporting year which showed 45, 33 and 30 breaches consecutively, so the trend is down over the year which is a welcome development.

As a result of these consecutive breaches over a sustained period these have been scored a CCS category 3 breach of permit requirements.

The annual tracking spread sheet of breaches has been sent to you separately as a guide to the areas for improvement.
