Site Inspection – 24/10/14.

A general low amount of on-site odour was noted during the inspection and no off site odours were noted prior to or after the site inspection. No breaches of the permit conditions were noted during the walkover. Findings from the audit carried out in August were discussed with the site manager.

Quarterly Monitoring Reports.

We have reviewed the following quarterly monitoring reports required by Condition 4.2.2 of the Permit: Llanddulas Landfill site quarterly environmental monitoring report 1st May 2014 to 31st July 2014 and 1st August 2014 to the 30th October 2014

Groundwater.

Requirements - Condition 3.6.1(c) requires monitoring of groundwater quality as per tables S4.4 & 4.10 of the permit. Condition 3.2.3 states that the trigger levels for emissions into groundwater shall not exceed the levels set out in S.4.4.

Findings - No exceedances due to potential contamination from the landfill site for ground water quality were noted in either monitoring period. Some elevated ammonia was noted during the summer period due to generally low water volumes in the well and potential stagnation.

Fugitive Emissions Monitoring.

Requirements - Condition 3.3.5 states the limits for landfill gas arising from the installation shall not exceed the limits set in table S.4.11. Flame Ionisation Detector (FID) surveys are required to be conducted monthly at the site boundary and in the immediate vicinity of gas and leachate well heads and monitoring points.

Findings - FID surveys carried out during the monitoring period 1st May 2014 to 31st July 2014 found a total of 21 breaches of the 1000ppm permit limit for fugitive methane emissions in the vicinity of gas and leachate well heads. This is an increase in comparison to the previous reporting quarter, in which only 11 breaches were recorded. . Complaints of landfill gas odour received by NRW steadily increased during this monitoring period.

Gas Infrastructure LC3A, D276, and D248 are noted as exceeding the permit limit on consecutive months.

FID surveys carried out during the monitoring period 1st of August 2014 - 31st of October 2014 found a total of 24 breaches of the 1000ppm permit limit for fugitive methane emissions, with the majority of these breaches occurring in September and October. It is notable that only 3 FID breaches occurred in August and NRW only received 8 complaints during this month. 29 odour complaints were received by NRW during September and 20 during October corresponding with the rise in FID breaches for these months.

Gas Infrastructure D268, D281, D283, D268 and D269 are noted as exceeding the permit limit on consecutive months.

As a result these emissions have been scored a CCS Category 3 breach of the permit requirements.

Lateral Migration of Gas.

Requirement - Condition 3.1.2 Schedule 4, S4.5 requires Methane concentrations in perimeter boreholes to be less than 0.5% above background.

Findings - No breaches of external gas borehole limits were noted for either monitoring period.
