Fugitive Emissions Monitoring

Report covering the period of 01st August 2016 - 31th October 2016

Requirements - Condition 3.3.5 states that the limits for landfill gas arising from the installation shall not exceed the limits set in table S.4.11. of the permit. The permit requires Flame Ionisation Detector surveys to be conducted monthly at the site boundary and in the immediate vicinity of gas and leachate well heads and monitoring points.

Findings - The FID surveys over this monitoring period showed that on 41 occasions, the infrastructure features monitored exceeded the permit limit of 1000ppm. This is an improvement on the previous quarter in this reporting year which showed 68 breaches, so the trend is down over the quarter which is a welcome development.

There were three consecutive breaches recorded in this quarter for the following wells; LCP03, D305, D299, D283 and LMP3/2. There were other consecutive breaches but they were rolling breaches from the previous quarter. For future reference any rolling breach of three consecutive readings above 1000ppm as well as such consecutive breaches within the reporting quarter will be scored.

As a result of these consecutive breaches over a sustained period these have been scored a CCS category 3 breach of permit requirements.

The annual tracking spread sheet of breaches has been sent to you separately which highlights all of the breaches by year and quarter for information.
