Quarterly Monitoring Report.

Following a review of the quarterly monitoring report for the period covering the 1st August 2015 -31st October 2015, submitted as required by condition 4.2.2 of the Llanddulas Landfill Site permit, I have made the following observations;

Groundwater.

Requirements - Condition 3.6.1(c) requires monitoring of groundwater quality as per tables S4.4 & 4.10 of the permit. Condition 3.2.3 states that the trigger levels for emissions into groundwater shall not exceed the levels set out in S.4.4.

Findings - During this reporting period there was one breach of the specific trigger limit for Potassium in borehole GWBH36. A potassium value of 18mg/l (trigger limit 12mg/l) was recorded in the sample collected during the October sampling round – a Schedule 6 notification was submitted to NRW for this breach. The value recorded was a reduction on the 36mg/l concentration reported in April and 22mg/l in July. This shows a continuing level of reduction in the concentration of potassium in the borehole following purging, therefore a **CCS score of 4 has been attributed to this breach.**

Fugitive Emissions Monitoring.

Requirements - Condition 3.3.5 states the limits for landfill gas arising from the installation shall not exceed the limits set in table S.4.11. Of the permit. The permit requires Flame Ionisation Detector (FID) surveys to be conducted monthly at the site boundary and in the immediate vicinity of gas and leachate well heads and monitoring points.

Findings - The FID surveys over this monitoring period showed that on 45 occasions the infrastructure features monitored exceeded the permit limit of 1000ppm. Gas Infrastructure wells D260 and D293 are noted as exceeding the permit limit on three consecutive months. LC3A, D263, D283, D289, RD187, D268, D294, D270, D290, D274 exceeded the permit limit on 2 consecutive months.

As a result of consecutive breaches over a sustained period these have been scored a CCS Category 3 breach of permit requirements.

Please see attached spread sheet detailing the exceedances for the current financial year. This also allows the tracking of individual feature exceedance over the annual cycle. It was agreed during the site audit on the 26th November that Infinis will work with the site manager following 2 consecutive breaches at the same feature to identify the problem with the feature and ensure that it does not breach for the third consecutive month. A short bullet point e-mail report should be provided to NRW of actions taken to prevent a third consecutive breach.
