An operator monitoring assessment (OMA) air was carried out by Natural Resources Wales officers on 5 December 2014, the overall results for this assessment were 93%. This demonstrates that Tata Steel has a high level of environmental control over monitoring of emissions to air from the installation. Details of the OMA can be found in the attached reports.

Recommendations for improvement are:-

OMA 1C - Update monitoring schedule for all staff to view.

OMA 1 E - To include a training plan that outlines the needs and capabilities of monitoring staff and to include regular reviews.

OMA 2 A & OMA 3 A - To increase score for this section sampling locations would need to meet the requirements of M1 guidance.

OMA 2 B - Investigate feasibility of MCERTS accredited Lancom when replacing kit.

OMA 3 B - CEMS would need to meet requirements of MCERTS to increase score.

OMA 4 C - To increase score Level 2 MCERTS training would be required and a training plan needed.
