CQA Validation Report Assessment – Ground Water monitoring borehole

Condition 2.7.4 of the permit states “No construction of landfill infrastructure shall commence until the operator has submitted relevant construction proposals or a written request to use previous construction proposals and the Agency has confirmed that it is satisfied with the construction proposals.

Compliance assessment of the CQA plan was undertaken and recorded via email dated 24/5/16 which stated “I’m unable to create a compliance Assessment report at this time (internal system problems) however please accept this email as confirmation that NRW is satisfied with the CQA plan for the 2016 permanent capping works in accordance with requirements of condition 2.7.4 of the permit.”

Assessment was made following submission by FCC received on the 23 May 2016 of

- the original CQA plan (479-SW-2013-24) from our archives, the amended addendum you have forwarded referenced 479-SW-2016-07

Your permit (condition 2.7.6) requires the operator to submit a CQA Validation report, following construction of any relevant landfill infrastructure.

Following the completion of the capping works the following document was submitted, by the operator’s consultants, in order to discharge condition 2.7.6:

NRA can now confirm that it is satisfied with the CQA Validation Report for the permanent capping undertaken in 2016 in accordance with the requirements of condition 2.7.6 of your PPC Permit
