Having reviewed the document 479-SW-2017-05/01 showing the area intended to be capped, and the previously accepted CQA plans 479-SW 2016/07 V1.1 Pwllfawatkin cap CQA plan addendum V1.1 and 479-SW-2013/24, I am able to provide confirmation that NRW is satisfied with the CQA plan for the additional 2017 permanent capping works in accordance with requirements of condition 2.7.4 of the permit.

Please note that the acceptance of the CQA plan for the permanent capping by NRW does not mean the assumptions, design specification, testing regimes will be suitable for future developments at the site.
