Condition 2.7.4 of the permit states "No construction of landfill infrastructure shall commence until the operator has submitted relevant construction proposals or a written request to use previous construction proposals and the Agency has confirmed that it is satisfied with the construction proposals.

On the 24th February 2017 the report titled "Infinis Energy Services Ltd. Pwllfawatkin Landfill Site Retro Drilling of Gas Wells Construction Quality Assurance Plan February 2017" was received by NRW via email.

Having assessed the CQA NRW can confirm acceptance with the following comments:

- Please ensure that the CV of the CQA inspector is forwarded to me with sufficient time for me to check the details prior to works commencing on site

Following construction of the gas wells FCC are required to forward a CQA validation report as per condition 2.7.6 of the permit "The operator shall submit a CQA validation report as soon as practicable following the construction of the relevant infrastructure"
