This Compliance Assessment Report (CAR) form was completed by Ffion Thomas following the announced audit of Pwllfawatkin landfill undertaken on the 26th April 2018.

The audit was a follow up to audit CAR-NRW0033347

The audit consisted a site meeting with both FCC site manager Richard Thomas and the sites gas contractors Infinis represented by George Augood.

During this visit discussions were had as a follow up on odour management at the site and focused on the operators plans to mitigate odour during the next operational phases.

Infinis confirmed the recently installed (17th April 2018) pin wells were on line and drawing approx. 50m3 a day



Future tipping phases were discussed, and FCC confirmed that the tipping plan was to work across the sidewall cell west to east.

As this second lift of waste is progressed and completed a permanent gas line and wells are planned to be installed along the southern flank, and could be undertaken as soon as September (dependant on waste inputs)

The pin wells will remain and continue to be kept operational even after burying.

The southern flanks will again be temp seal capped by September when based on current inputs the 2nd lift is estimated to be complete (as per the first lift)

The permanent capping of the flanks is estimated for later in 2019.

A continual review of the gas management is undertaken between FCC and Infinis and this work is encouraged.

No non-compliances were identified during this inspection.
