Condition 2.7.4 of the permit states "No construction of landfill infrastructure shall commence until the operator has submitted relevant construction proposals or a written request to use previous construction proposals and the Agency has confirmed that it is satisfied with the construction proposals.

A further email was received on 9/4/18 in response for clarification request of the plan drawing. The titled Proposed wells plan. drawing no. 5390_PW17

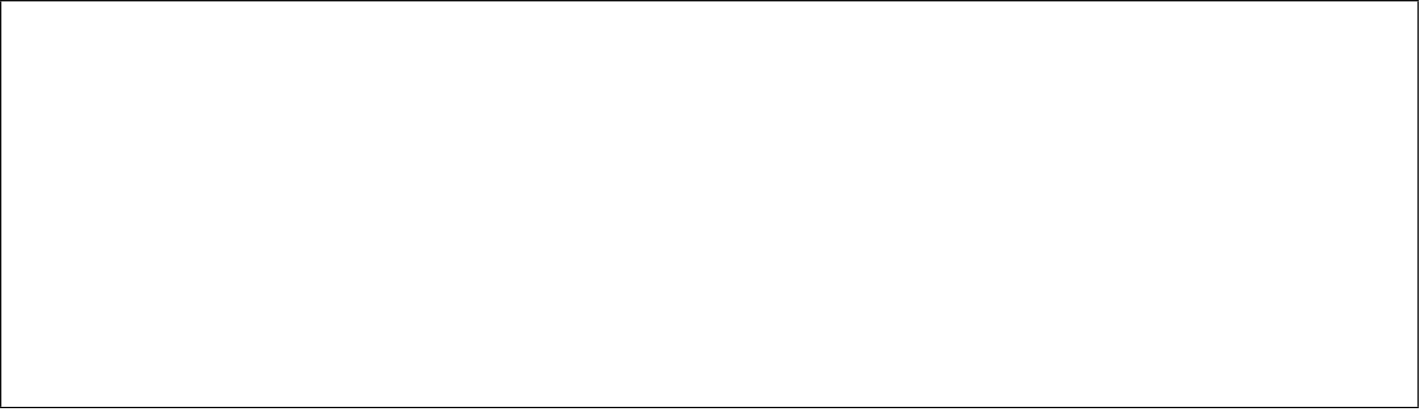
Having assessed the CQA and additional drawing confirmation NRW acknowledge acceptance of the CQA plan.
