Condition 2.7.6 of the permit requires the operator to submit a CQA validation report following construction of any relevant landfill infrastructure.

The above document is received in compliance with this above condition.

Condition 2.7.4 of the permit states “no construction of landfill infrastructure shall commence until the operator has submitted relevant construction proposals or a written request to use previous construction proposals and the agency has confirmed that it is satisfied with the construction proposal

On the 2nd November 2017 FCC undertook and submitted an odour action plan that detailed the infrastructure work of installing horizontal gas wells to improve site environmental performance. In compliance with the above condition.

Following review of the Infinis Energy Services Ltd Pwllfawarkin landfill site Installation of Horizontal Gas Wells Installation Report. NRW can now confirm that it is satisfied with the CQA validation for the installation of the horizontal gas wells in accordance with the requirements of condition 2.7.6 of the permit.

Please note that the acceptance of this CQA validation by Natural Resources Wales does not mean that the assumptions, design, specifications, testing regimes will be suitable for any future infrastructure developments at the site.
