This compliance assessment report was completed following review of the CQA validation report for the 2017 capping construction works at Pwllfawatkin landfill site. Document reference WR7334/5/001 September 2017.

Condition 2.7.4 of the permit states “no construction of landfill infrastructure shall commence until the operator has submitted relevant construction proposals or a written request to use previous construction proposals and the agency has confirmed that it is satisfied with the construction proposal.

A previous CAR report was completed ref CAR\_NRW0031407 accepting the CQA plan for permanent capping.

Condition 2.7.6 of the permit requires operators to submit a CQA validation report following construction of any relevant landfill infrastructure.

Following completion of the permanent capping works undertaken in 2017 the following documents were submitted in order to discharge the above condition.

CQA validation report ref WR7334/5/001 September 2017 QA validation report for the 2017 capping construction works at Pwllfawatkin landfill site was received via email on 26/9/17

Following review of the document follow up emails were received on the 9/10/17 confirming and providing confirmation to questions raised regarding geocomposite overlap and provision of a missing appendix giving the total lining operations by the lining company.

**NRW can now confirm that it is satisfied with the CQA validation Report for the permanent capping undertaken in 2017 in accordance with the requirements of condition 2.7.6 of your permit.**

**Please note that the acceptance of this CQA validation by natural Resources Wales does not mean that the assumptions, design, specifications, testing regimes will be suitable for any future infrastructure developments at the site.**
