Review of emissions monitoring data for quarter 1 and 2, 2014.

It is noted that monitoring of the leachate head is only being carried out on a quarterly basis. Schedule 4, table S4.1 of your environmental permit (GP3030BE) specifies that leachate levels should be monitored monthly. This is a breach of condition 3.6.1 of your permit and attracts a CCS category 4 score. Please ensure that monitoring of this parameter is carried out at a monthly frequency.

Elevated levels of Zinc have been found in borehole 1 at the end of Q1, although it is unknown whether these are directly attributable to the operation of the landfill and as such have not been scored a CCS score.
