Emissions to Air

Review of annual emission monitoring (2014) for combustion plant across site, emission points A6, A7, A8 - monitored for Oxides of Nitrogen (Nox) and Carbon Monoxide (CO) - noted all results for combustion plant below permitted limits.

Review of annual emission monitoring (2014) for coating lines, monitoring carried out for VOC's, Nox and CO on emissions points A12, A12a, A21 - noted emissions monitored show results below permitted limits.
